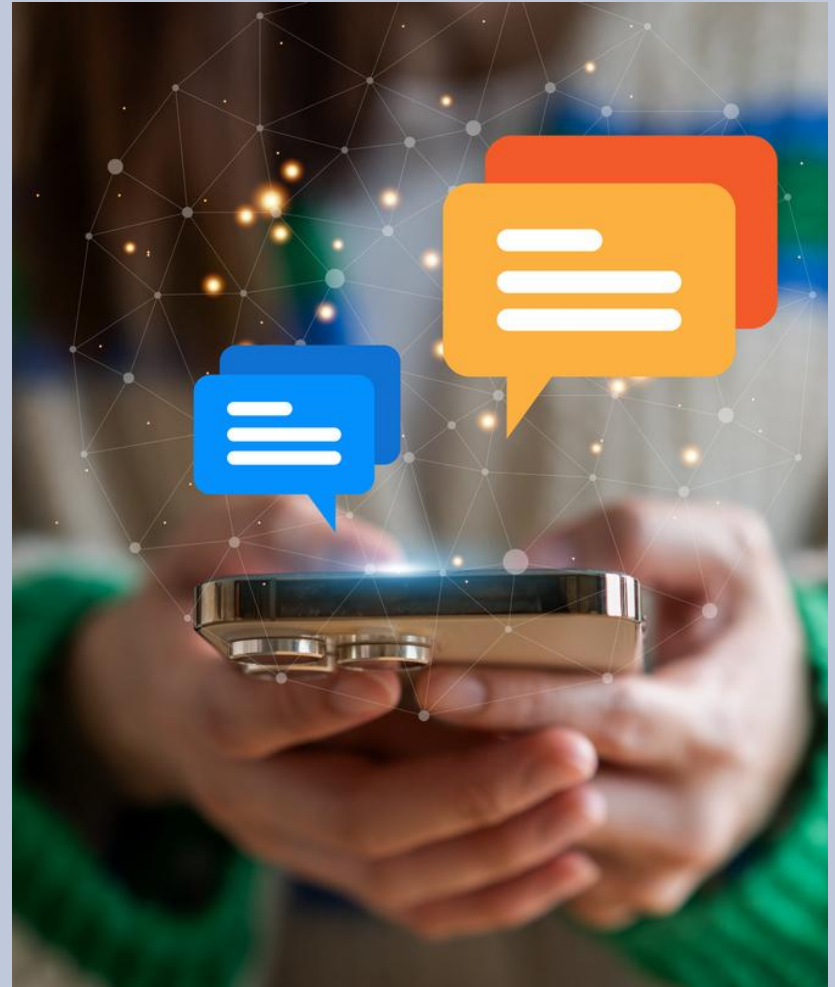

## 10DLC Registry

Mobile carriers created a centralized system for registering 10-digit long code phone numbers used for business text messaging campaigns to combat spam and ensure businesses use SMS responsibly.

Businesses must register their 10DLC numbers and intended use cases with the Registry or face stiff penalties.

## Penalties for sending unregistered traffic

Blocked Messages

Hefty Fines

Reputation Damage

Despite the creation of the 10DLC Registry in 2023, many businesses (even if they are unaware) send messages from unregistered numbers. Over the last few years, the 10DLC ecosystem has aggressively pushed to end all unregistered traffic.

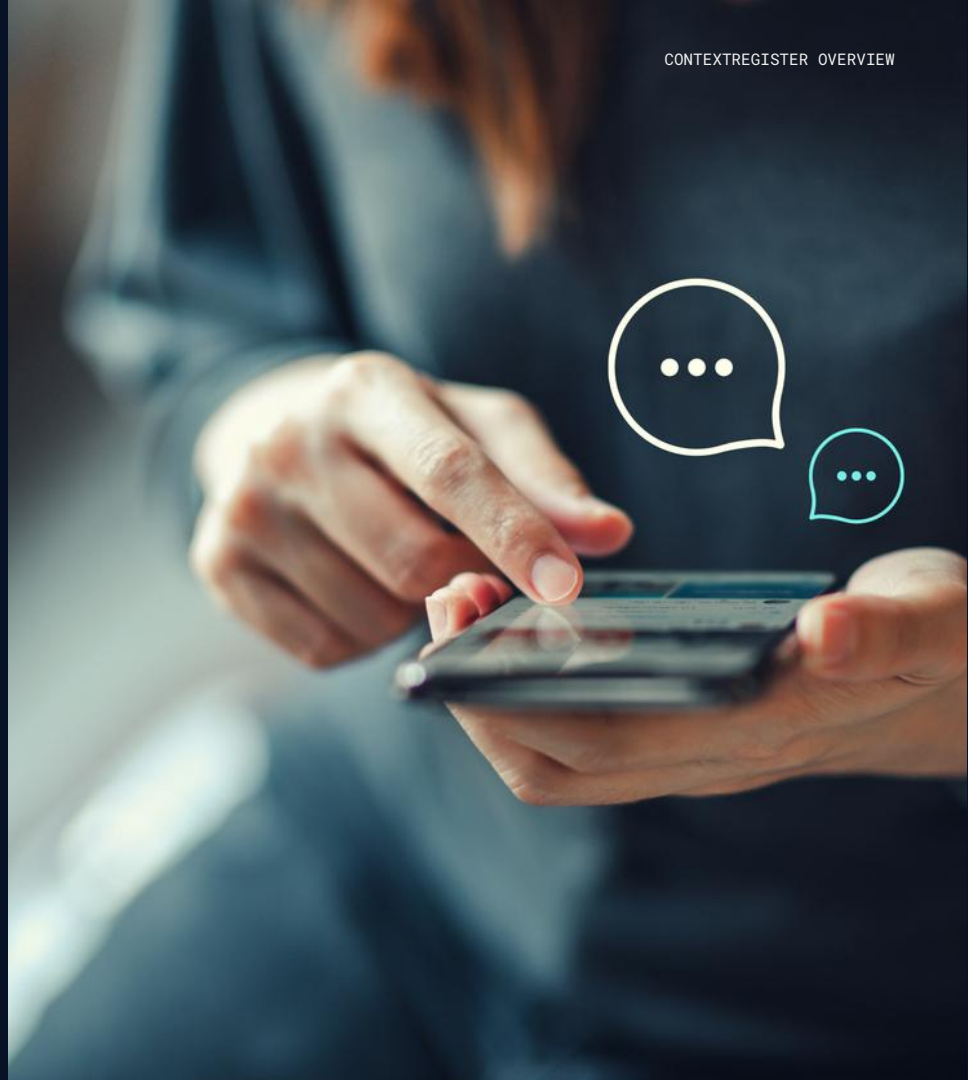

- Integration challenges with messaging solutions



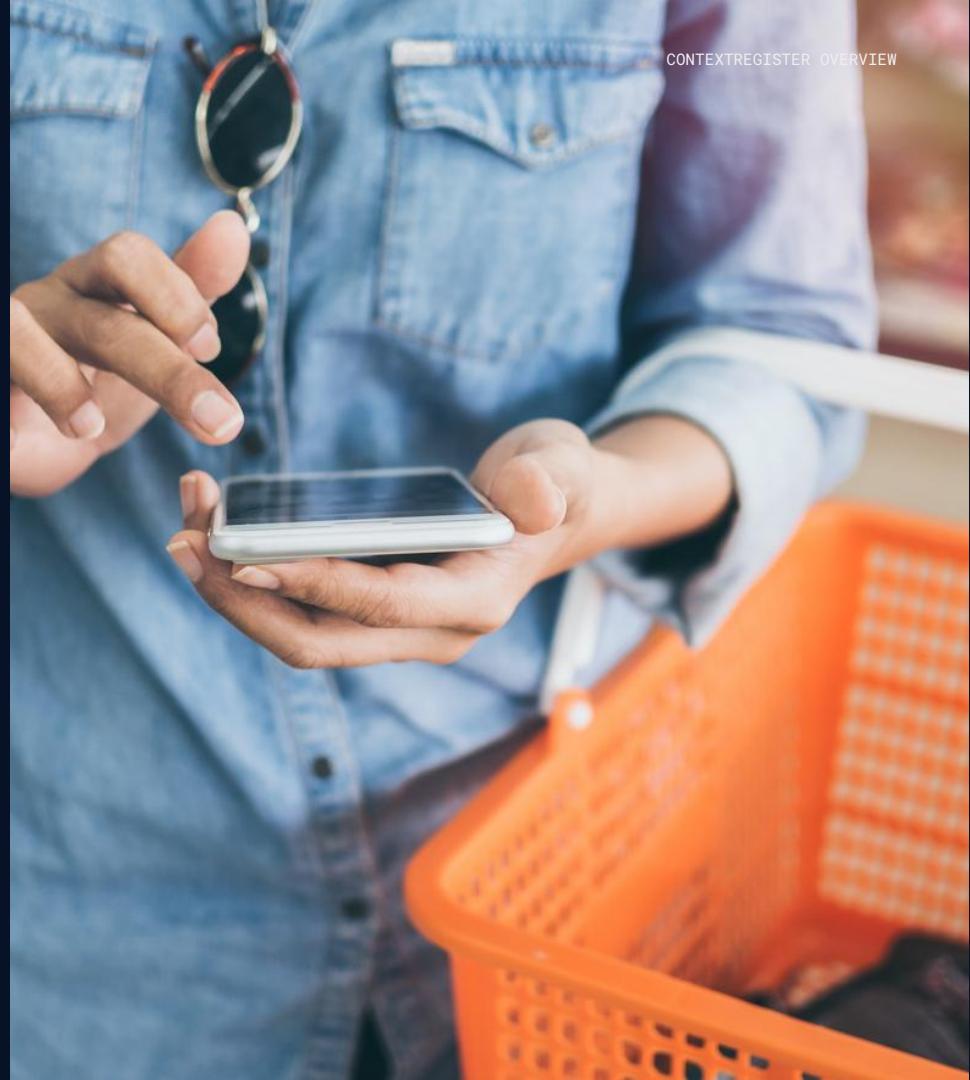
# Challenges for CSPs

- **Administrative overload**  
CSPs are overwhelmed with the number of brands needing 10DLC onboarding & registration
- **Lack of visibility & control**  
CSPs struggle to track the registration process of multiple brands, leading to limited insight into approvals
- **Risk of non-compliance and penalties**  
Failure to comply with TCR guidelines exposes CSPs and their brands to financial penalties & service disruptions
- **Integration challenges with messaging solutions**  
CSPs have no way to centralize brand registrations and must be compatible with a multitude of SMS providers
